Please include it in the reference.</p> <p>Geurt (2006) is also not found in the reference. Kindly include it.</p> <p>Kurniawati (2016) is also not cited in the reference. Kindly include it.</p> <p>Afriani and Setiyani (2015) is missing in the reference list. Kindly include it.</p> <p>Masdonati et al. (2009) is not found in the reference list.</p> <p>Hair et al. (1998) and (Hair et al., 2013) are also missing in the reference list</p> <p>Hafidh (2019). Is also missing in the reference.</p> <p>Ngaini (2017) is not listed out in the reference.</p> <p>Zainuddin (2022), Palan (2007), Fuad (2009), Bandura (1986), Ghufron & Suminta, (2013), Feist et al., (2017), Sunda Yen (2012) are not mentioned inside the manuscript but they are missed out in the references. Kindly include them.</p> <p>Mention the year of publication for Apriani, A. In the reference list.</p> <p>The following authors are mentioned in the list of references but their works are not mentioned inside the manuscript. Therefore, the author has to remove them from the reference list.</p> <p>Amir, H.
