Results are presented; however, it is not properly discussed with the findings from other related literatures to validate the results. Hence, result and discussion section should be revised accordingly. Also, numbering should be adjusted properly in result and discussion section like 4.1, 4.2....</p> <p>References and citations should be re verified for the confirmation of proper citation and references.</p>
