Please check the manuscript carefully for typos and grammatical errors. I found some typos and grammatical errors within this manuscript, which have been excluded from my review. In addition, the English structure of the article, including punctuation, semicolon, and other structures, must be carefully reviewed.</p> <p>2-In the introduction, the authors did not provide a strong motivation for the paper and the obtained results. In addition, they should discuss the main contributions of their work in detail after the motivation part. Then they should summarize the main structure of their paper in brief at the end of the introduction.</p> <p>3-The literature review about the problem under study is not adequate. I suggest the authors keep up-to-date the introductory part by the recent relevant developments and publications.</p> <p>4-For this purpose, the authors can add the following references to enrich the introductory section:</p>
