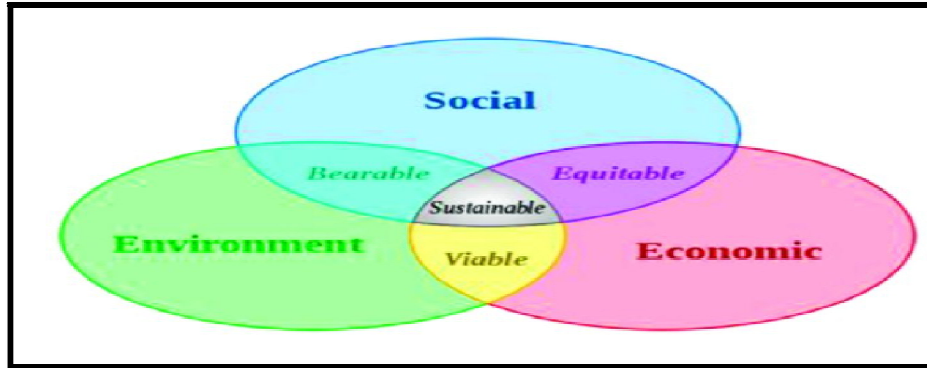


Figure 1 show the three dimensions of sustainability (source)(wikipedia, 2021)
