The work is relevant to agri-food production and addresses an important gap in ensuring product traceability, which is crucial for enhancing the competitiveness of food products in local and international markets. The manuscript also highlights key challenges in traceability, such as document management and coding procedures, which adds value to practical industry applications.
