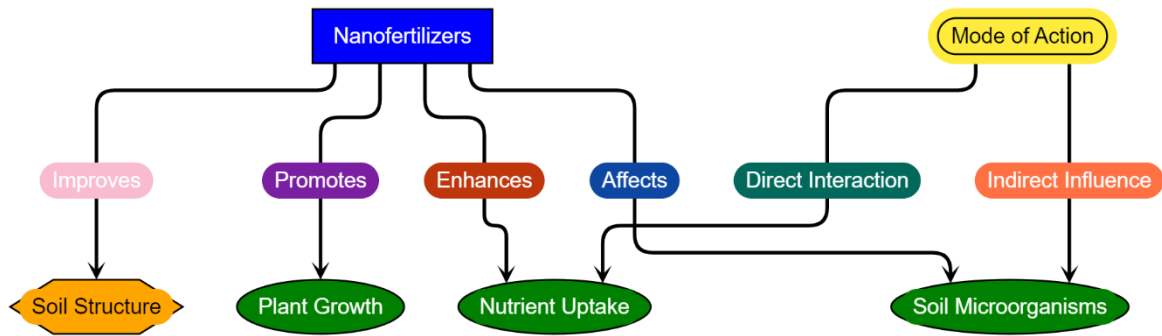


Figure 1. Nanofertilizers functions and mode of action

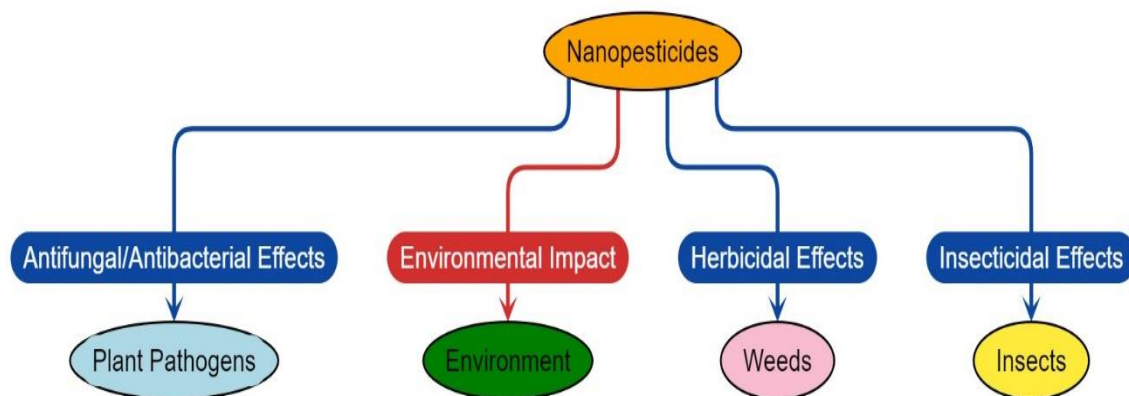


Figure 2. Effects of Nanopesticides
