Compulsory REVISION comments	<p>The word “climate change” is used as an adjective.</p> <p>Climate change is a vast subject – see for definition WMO [1966], IPCC & UNFCCC [Article 1]. Also see WMO (1966, manual on “Climate Change” for data period requirement to understand natural variability in rainfall. This manual also presented methodologies];</p> <p>Global level changes if any have no role at local/regional levels – see publications on Indian temperature trends using historical data series at state level and national level.</p> <p>Abstract – delete first 6 lines;</p> <p>1.Introduction –</p> <p>Para 1 – delete the first 8 lines except the last two words “Agriculture sector”; delete the last 4 lines and “to” in 5th line;</p> <p>Para 2 – delete</p> <p>Paras 3 to 8 – change the word “climate change” by the words “weather/climate”</p> <p>2.Material and Methods:</p> <p>2.1 – delete “C” in lines 4 & 5</p> <p>3. Results & Discussion:</p> <p>4. Variability:</p> <p>Delete either “rainfall” or “precipitation” as both are the same; and the author can add “snowfall”</p> <p>Delete para 1 “climate variability --- below”</p> <p>Important point – the author used “2000-2014” data, which is negligible when compared to the natural variability in rainfall [60-year cycle], river water flows following this cycle.</p> <p>During 2002 & 2009 at all India level presented drought and thus temperature presented a rise. Same way in Figure 5 [Dehra Dun] rainfall for 2010 – 2013 showed higher and correspondingly the temperatures were lower in Figure 8;</p>	
Minor REVISION comments	<p>Very few typing minor corrections</p> <p>Change “climate change” as “weather/climate”</p> <p>As per suggestions, need deletion of some references</p>
