In addition, I recommend to follow the author's guideline in the web site page. ↳ Include ACKNOWLEDGEMENT ↳ Use APA style for reference writing. <p>I indicated it in the mother document by shading RED COLOR.</p>	
Minor REVISION comments	<ul style="list-style-type: none"> √ Abbreviation shouldn't be used in the abstract √ 'INFLUENCE' avoid it from list of key words. <p>I indicated it in the mother document by shading YELLOW COLOR.</p>	
Optional/General comments	<p>⇒ I recommend the author to follow 'the principle people first, disability second (Foreman, 2000) description' throughout the entire document. E.g.
