All articles in a journal issue should have basic criteria which makes it complete for selecting our articles. The basic criteria include,

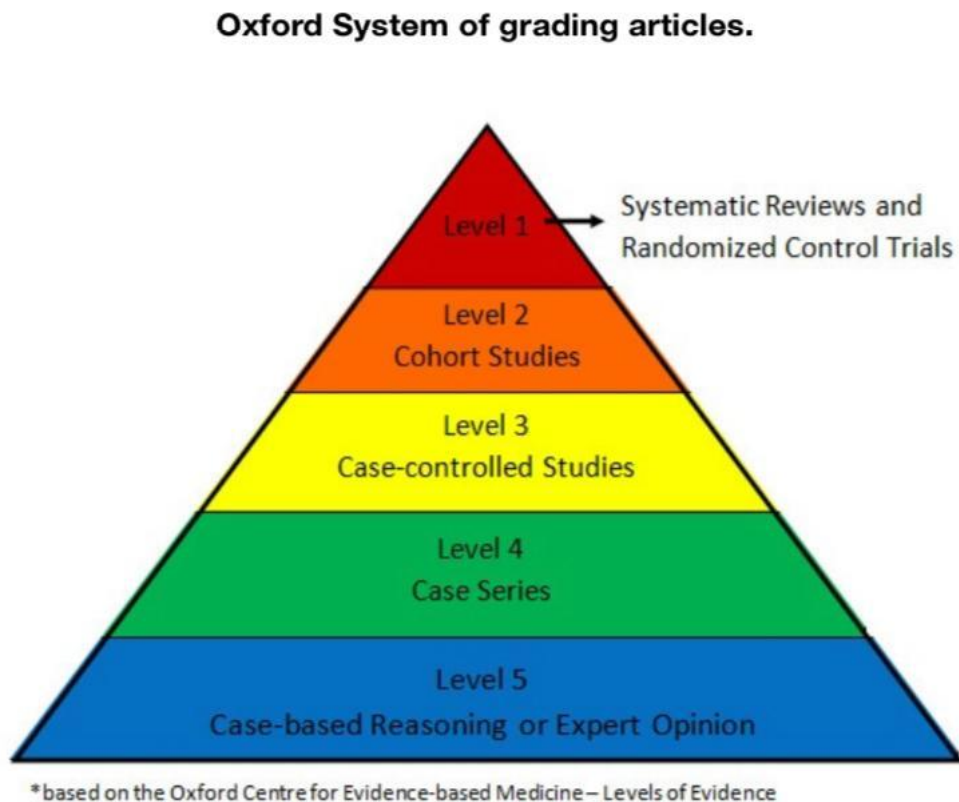
- Original or review articles

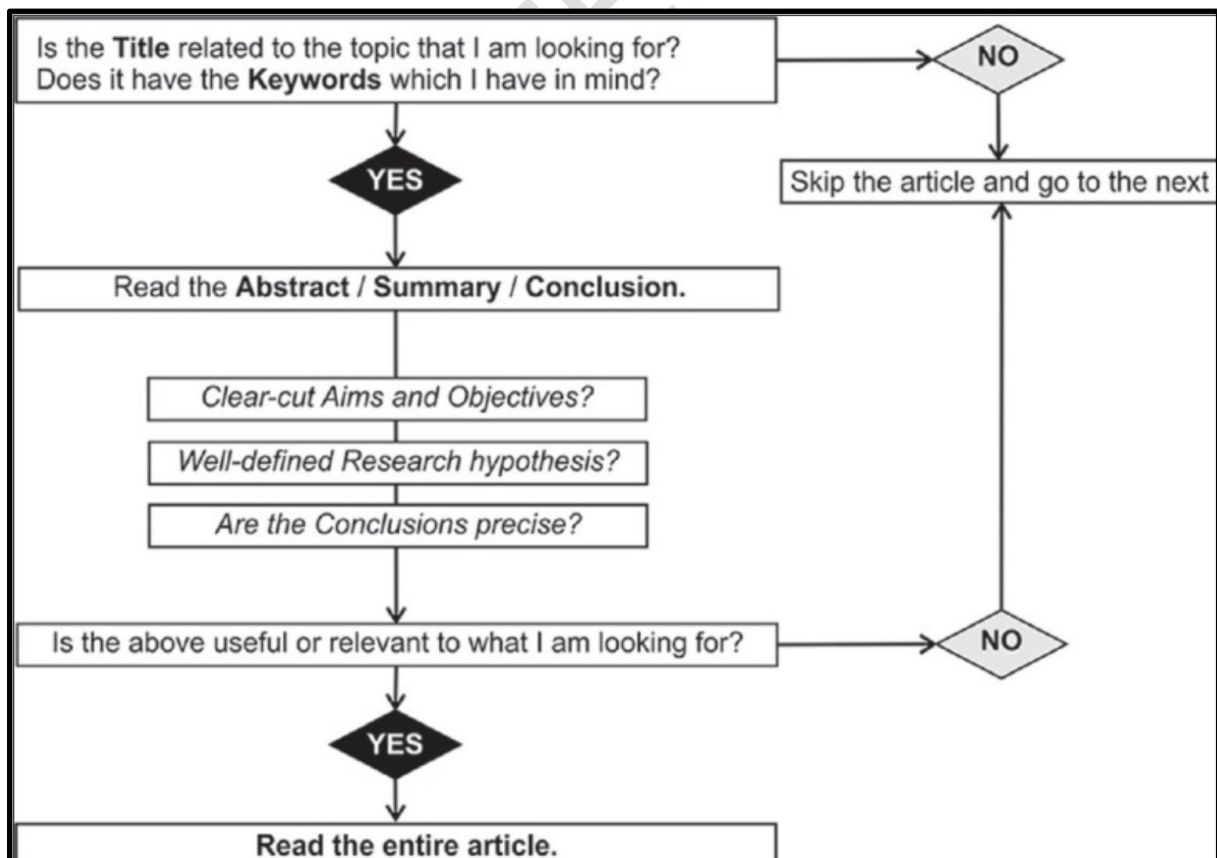
SELECTING THE FINAL ARTICLE :

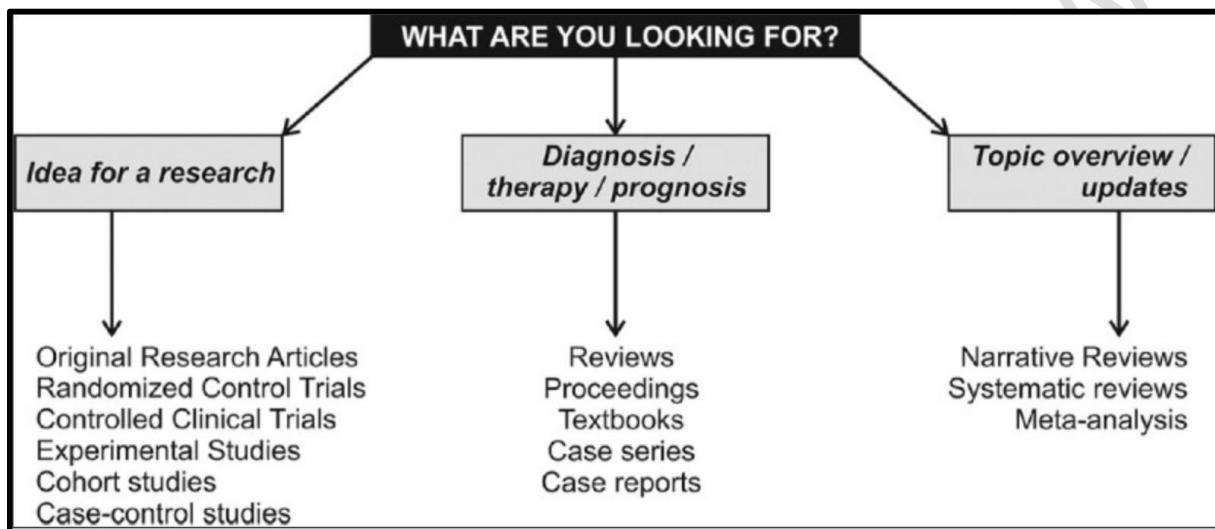
