Minor REVISION comments	<ol style="list-style-type: none"> 1) Provide descriptions to the tables so that they may stand alone. 2) Re-write the results section to do more than just describe figures. 3) Work with the copy editor on improving the writing Style, particularly in the results and discussion. 4) Revise the introduction to more closely match the emphasis on vibration for spasticity management in the discussion. 	
Optional/General comments	<ol style="list-style-type: none"> 1) Consider referring to "subjects" as "participants". 2) Provide minimal clinically important differences for the GMFM and analyse the changes between groups with this more clinically relevant data.
