<b>Compulsory</b> REVISION comments	<p>MS_JPRI_80456</p> <p>Title: Medicinal Properties of Terminalia Arjuna: A Review</p> <p>This is a very interesting manuscript. However, in order to be published, it is recommended to modify the following few things.</p> <ol style="list-style-type: none"><li>1. This review paper is about the medicinal properties of <i>T. arjuna</i>. According to the PubMed survey, there are more than 1,000 papers and 100 review papers about <i>T. arjuna</i>. To be a new review paper on <i>T. arjuna</i>, which has been studied a lot for a long time, the completeness is not enough, so it is better to rewrite it..</li><li>2. Table 2 summarized the main phytochemical components contained in <i>T. arjuna</i>. However, some of the components listed in Table 2 are missing references. For example, there are seven references in PubMed to casuarinin contained in <i>T. arjuna</i>. Therefore, it is necessary to re-examine the references for the ingredients cited in Table 2.</li><li>3. Since the name of <i>T. arjuna</i> is divided into a genus name and a species name, I think that it cannot be written as <i>T. ARJUNA</i>.</li><li>4. About abbreviations: The use of abbreviations in the abstract is used separately from the text. That is, it is not necessary to specify abbreviations for abbreviations that are not used repeatedly in the abstract. Define CADs and CHF. And, after specifying the full name and abbreviation of a specific term from the introduction part, you can use the abbreviation to the conclusion part.</li><li>5. English: The manuscript has numerous grammatical and typographical errors that should be corrected. It is absolutely necessary to get a proofreading from a professional English language-editor.</li></ol>	
<b>Minor</b> REVISION comments	<ol style="list-style-type: none"><li>6. Units are written with a space after the number. There are also several typos for this matter. Examples: 12.5µg/disc should be 12.5 µg/disc. IC50 should be IC<sub>50</sub>.</li><li>7. Reference section: Author should consult and peruse carefully recent issues of the journal, <b><i>Journal of Pharmaceutical Research International</i></b>, for format and style. The first letter of the title must be in upper case, and the rest must be in lower case.</li></ol>	
<b>Optional/General</b> comments	<p><b><u>Overall, the manuscript can be considered to publication after major revision as indicated above.</u></b></p>
